**Action Requested:** Select Board Officers

**Recommendation**

Make nominations and select a Board Chair and Vice-Chair for calendar year 2015.

**Discussion**

The STA’s Rules for Proceedings require that your Board select a Chair and Vice-Chair at the first meeting after January 1st of each year. The Chair presides over each meeting, maintains orderly procedure, and rules on all procedural matters or questions not specifically covered by the Rules for Proceedings, subject to appeal to the Governing Board. He/she may vote and participate in discussions on any matter, and may make or second any motion without having to relinquish the Chair. He/she also serves on the Measure A Independent Taxpayer Oversight Committee.

When the Chair is absent or unable to act, the Vice-Chair presides over meetings. In the absence or inability to act of both the Chair and Vice-Chair, the members may select a temporary Chair from among those present.
