Agenda Item #5

The committee will undertake a complete revamp of the Maintenance of Effort standards. It was
agreed that the process would begin by meeting with the appropriate management/staff of
each Measure A entity to discuss and propose appropriate standards. The meeting is planned
for the second week in November. Once completed, the ITOC will recommend the changes to
the Board for their review and action as needed.

The committee asked that a sample Annual Bridge and Pavement Report be distributed to them
as they work with staff to develop a standardized reporting template. Staff recommended the
August 2017 report prepared by the City of Sacramento. Report subsequently emailed to all
members.

- Norm updated the committee on the last Board meeting. Most notably, STA is actively engaging local transit/transportation groups who want an opportunity to speak to the Board as it considers another Measure in 2020. As such, in each Board meeting through December, groups will be invited to speak.
- A resolution was approved by the Governing Board of the Sacramento Transportation Authority opposing Proposition 6, the November 2018 ballot proposition which would repeal Senate Bill 1, the Road Rehabilitation and Accountability Act of 2017.
