- 5. Presentation from the California Department of Transportation (Caltrans). Staff from Caltrans presented on the I-5 Managed Lanes Projects. This included the recently completed Interstate 5 (I-5) Corridor Enhancement Project from Elk Grove to Downtown and a discussion of the leveraging of Measure A funds with SB1 funding. Caltrans went on to present on the I-5 Managed Lanes projects from Downtown to the Airport highlighting the alternatives currently under consideration. STA Staff indicated that not all of the alternatives



were consistent with Measure A. The ITOC asked for more detail on the operational benefits of the project, VMT mitigation, and potential grant funding sources for design and construction. Caltrans then presented on the US 50 Multi-Modal Corridor Enhancements Project and fielded questions from the ITOC regarding change order costs, delays, and the use of Measure A funds.
